

**LIMITED WARRANTY**---Terms of the Manufacturer's warranty are listed below:

This limited warranty is given by LEDnovation to the original purchaser of the product, which is not transferable to any third party.

**THE PRODUCT IS WARRANTED AGAINST DEFECTS IN MATERIAL OR WORKMANSHIP FOR A PERIOD OF FIVE YEARS FROM THE DATE OF PURCHASE.** The limited warranty covers products that have completely failed and does not cover any failure caused by the following:

- a. Improper installation/operation (reference individual product specification sheet for examples)
- b. Failure to follow product instructions or user manuals
- c. Improper maintenance
- d. Accidental damage, abuse or misuse
- e. External causes or Natural catastrophe
- f. Normal wear and tear
- g. Damage caused as a result of transportation, includes returned product
- h. Minor aesthetic imperfections that do not alter or affect functionality of the product
- i. Repairs or alterations not authorized or performed by LEDnovation
- j. Abnormal electrical current/voltage surges
- k. An application in any way different from that for which the product was designed

The limited warranty covers lumen maintenance and color shift as identified below:

**LUMEN MAINTENANCE**

**FAILURE DUE TO LUMEN MAINTENANCE IS DEFINED AS LUMEN DEPRECIATION OF GREATER THAN 30% WITHIN 25,000 HOURS OF OPERATION.** Lumen depreciation will be determined by measuring the bulbs current lumen output and comparing it to the lamps initial lumen output as measure at the time of manufacture.

**COLOR SHIFT**

**FAILURE DUE TO COLOR SHIFT IS DEFINED AS ANY LAMP THAT EXCEEDS THE CORELATED COLOR TEMPERATURE (CCT) TOLERANCES LISTED BELOW:**

Color Shift will be determined by measuring the current color temperature of the lamp(s) in question and comparing it to the lamp(s) original color temperature as measured at the time of manufacture.

If any of LEDnovation's products fail to meet the applicable warranty described above LEDnovation shall correct the defect by shipping to the purchaser either (at LEDnovation's option) the necessary repaired or replacement parts F.O.B. LEDnovation factory with freight allowed to destination within the Continental United States or Canada provided that the purchaser promptly gives LEDnovation written notice of any product defect within thirty (30) days after discovery of the defect and, if requested by LEDnovation, promptly arranges to make the product available to LEDnovation for investigation and correction **NO PRODUCTS MAY BE RETURNED UNTIL THE PURCHASER HAS CONTACTED LEDNOVATION AND RECEIVED A RETURN AUTHORIZATION.**

THE FOREGOING WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES. EXCEPT AS SPECIFICALLY SET FORTH ABOVE, LEDNOVATION MAKES NO REPRESENTATIONS OR WARRANTIES, AND EXPRESSLY DISCLAIMS ALL REPRESENTATIONS AND WARRANTIES, EXPRESS OR IMPLIED, RELATING DIRECTLY OR INDIRECTLY TO ANY PRODUCTS MANUFACTURED OR SOLD BY LEDNOVATION, WHETHER ORAL, WRITTEN, OR ARISING BY COURSE OF DEALING OR USAGE OF TRADE INCLUDING WITHOUT LIMITATION ANY WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. THIS LIMITED WARRANTY MAY BE MODIFIED OR AMENDED ONLY BY A WRITTEN INSTRUMENT SIGNED BY A DULY AUTHORIZED REPRESENTATIVE OF LEDNOVATION. WITHOUT AN EXPRESS, WRITTEN AUTHORIZATION FROM LEDNOVATION, NO DISTRIBUTOR OR SUPPLIER OF LEDNOVATION PRODUCTS HAS THE AUTHORITY TO MODIFY OR AMEND THIS LIMITED WARRANTY
